Telemonitoring of patients with domiciliary ventilatory therapies and sleep disorders.

Telemonitoring of biomeasures in cronic patients with cardio-vascular, hypertensive, oncologic, COPD and/or diabetic pathology

Domiciliary respiratory rehabilitation

Cleaning, maintenance and disinfection in the medical devices and medical equipment specific to Home Respiratory Therapies

Installation and maintenance of fire detection and alarm systems, using smoke detectors with optical alarm

Packaging, analysis and distribution of medicinal gases for the provision of oxygenotherapy services and supplies (compressed gas medical oxygen in gas cylinders and cryogenic liquid medical oxygen in portable cryogenic containers).
